The second round of the Working Holiday Programme 2025 will open on the **29th of September 2025**. The second round has a limit of 100 applicants and only the applicants who email their application between 9 and 10am (**Chilean time**) on **the 29th of September** will be considered.

The **Ireland-Chile Working Holiday Agreement** allows up to **200** young Chilean applicants (aged between 18 and 30) annually to take extended holidays in Ireland for up to a year, and to take employment as an incidental aspect of this stay. The aim of the scheme is to introduce young Chileans to the people, culture and landscape of Ireland and to allow them to work and study English or Irish there. Participants will have one year from date of issue of the authorization to enter Ireland. A similar scheme operates from Ireland to Chile.

You must follow the below procedures in order to submit your application to a working holiday authorisation:

1

Email us your application to the WHA 2025: There are 200 vacancies available for Chileans to participate in 2 rounds of this programme. **The second round** will be launched for the **WHA 2025** program **from 9 to 10 am (Chile time) on the 29th of September 2025**.

In order to ensure all people are given a fair and organized treatment you must send us **just one** email saying that you are interested in participating to the following mailbox:

IRISHWHCHILE@VFSGLOBAL.COM. The **100 selected candidates will be picked randomly from the pool of emails received** in the hour time period, and they will be assigned an appointment to apply for the Working Holiday Programme.

2

Attend the assigned appointment date and time: we will allocate an appointment date and time for your to submit your WH authorization application in our Application Centre. Please save the date/time designated for you.

3

Return of the decision envelope: The decision envelope with the authorization letter will be returned to you by a secured courier from VFS Office.

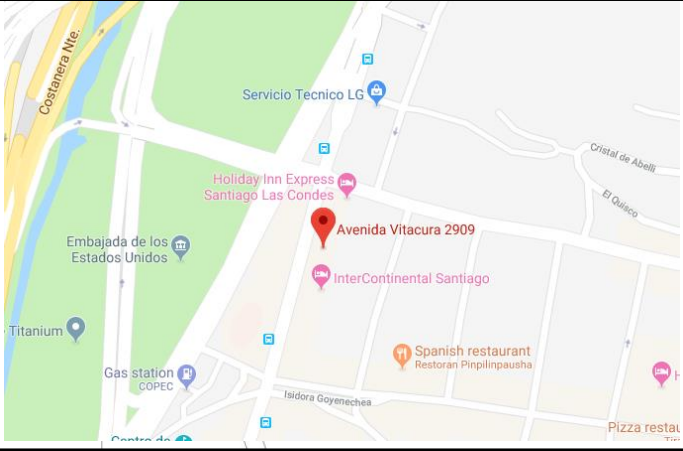

Below are the list of documents you must present in order to apply for your WH authorization

- **Fully completed application form: this must be completed in English (Please type form or use block capitals)**
- **2 recent photograph passport size:** Passport size, white background, no glasses. No lettering. 5x5cm in size.
- **1 Photocopy of details page of your valid passport**
- **1 Photocopy of police certificate of good conduct (antecedentes penales) issued within last 3 months of your appointment.**
- **Travel certificate from the Chilean Investigative Police (PDI) for a period of 6 months, where up to 15 days of departure from the country may be considered as a vacation period.**

Security Procedures at the Application Centre

- We cannot allow applicant's friends, relatives or other associates into the application centre.
- Applicants who have a disability or who are physically challenged will be able to bring somebody to assist them.
- The following items will not be permitted inside the visa application centre or stored in the premises: All battery operated or electronic gadgets such as cameras, audio/video cassettes, compact discs, MP3's, laptops, or portable music players.
- Sealed packages.
- Weapon or weapon-like objects or explosive material of any kind.

This list is not finite. Other items may be prohibited based on security staff discretion.

Please note: The application centre is unable to store prohibited items. Applicants should make other arrangements to store their belongings before they enter the application centre.

To book an appointment to the Santiago Application Centre you will need:

1. Send an email to IRISHWHCHILE@VFSGLOBAL.COM **between 9 and 10 am on the 29th of September 2025**
2. 100 emails picked randomly will be shortlisted by VFS.
3. If shortlisted, VFS will assign the appointment date/time for your application submission
4. Show your appointment confirmation email at the Application Centre

If for some reason you are unable to attend the scheduled appointment, please let us know within 48 hours of your appointment date/time. We will assign you another appointment as soon as possible.

If you do not confirm your appointment date/time and do not inform us with 48 hours notice, we will assign your appointment slot to a different applicant and depending on the amount of placements already filled, you may not be able to participate in the Ireland WHA 2025.

Once your appointment has been scheduled, the following fees must be paid by bank deposit or bank transfer (in two separate payments):

- Application Processing fee: **85 EU = CLP \$ 95.962**
- VISA fee: **60 EU = CLP \$ 67.738**

Proof of bank or wire transfers must be submitted along with the WHA application on the day of the appointment.

Fees are not refundable if your WH authorization is refused or you do not cancel your appointment with 48 hours notice.

ID	Question	Answer
1	Do I have to complete the application form online?	No, you must complete the form provided to you with the email, and bring it to the application centre at the date/time assigned for you. Filled in by computer not by hand.
2	What are the exact measurements of the photographs ?	Passport size, white background, no glasses. No lettering. 5x5cm
3	How long does it take to process my application at the Embassy?	The application process will take approximately 3 months, all WH Authorization applications submitted in September will be sent to the Embassy by December.
4	What documents I need to bring to my application?	You must bring: a fully completed computer application form, 2 recent passport-sized photographs 5x5, a photocopy of the details page of your valid passport and a photocopy of the police certificate of good conduct (antecedentes penales) and a travel certificate of 6 months (PDI). To be valid, your passport must have at least 2 years until the expiration date.
5	Do my work authorization letter returns by courier or I need to pick it up at the Visa Application Centre?	Documents can be collected in person at the Application Center at the designated dates and times.

ID	Question	Answer
6	Am I required to provide fingerprints or any biometric information?	No. This is not required.
7	Can I present my application at any date or time?	No, you will be informed by VFS of the appointment date and time you must present at the Santiago Application Centre .
8	Do I need to present an airplane ticket?	No this is not required. To be valid, your passport must have at least 2 years until the expiration date. Make sure your passport is valid for at least 2 years when your passport is being requested. Valid passport accepted only
9	Once I obtain my work authorization, how much time do I have to travel to Ireland?	The WHA is valid for entry to Ireland for 12 months after issue.
10	If I am granted the work authorization, when can I leave Chile?	As soon as you are granted the WH Authorization you are free to travel to Ireland. In addition to your authorization letter, at the port of entry you will need to show proof of travel insurance that covers the 12 month period and proof of your financial situation (you must have €1,500 if you have already booked return flight, or €3,000 without.)

11	What must I do with my work authorisation letter?	You must present your work authorisation letter to the immigration officer at Ireland's border.
12	How long can I work with one employer? How many employers can I have?	There are no restrictions on the number of employers or time of employment with a single employer once the WHA is issued.
13	How much money do I need to have in my account to present to VAC?	Chilean applicants are not required to present financial evidence at the application centre; however you may be asked to show proof of solvency at your port of entry; €1,500 with return flight, or €3,000 without.
14	I am 30 years old now but in 2 more weeks after my application is sent I will be 31. Can I still apply?	You must be under 30 years of age at date of application.
15	I have a child, will that cause my application to be refused?	Your family will not be a factor in your application; however the WHA is valid for one person only and no exceptions will be made.
16	My passport expires before the end of the visa, can I still apply?	Passports must be valid for the duration of your stay. When your passport is requested You must have a passport that is valid for at least 2 years prior to your application. Mandatory

17	I have a different signature for my passport and for my ID. Could that lead o my application being refused?	The signature on your application form must be the same as the signature your passport
18	When will the program will start in 2025?	Applications to the Ireland WHA 2025 programme will start the 2nd round on the 29th of September. Only emails submitted between 9 and 10 am (Chile time) on that day, will be considered on a randomly picked based on the VFS email platform.
19	How can I present my application to obtain a placement to the WHA programme?	You must send an email to IRISHWHCHILE@VFSGLOBAL.COM from 9 to 10 am on the 29 th of September. Chile time. We will respond to you with the appointment date/time to present your application.
20	I am a Chilean citizen but I am currently residing overseas, can I apply for to the Working Holiday Programme.	No , the Working Holiday Agreement is issued to Chilean citizens ordinarily residing in Chile. You must be living in Chile at least for the last 6 months at the time of your application. We will ask you for proof for this requirement. You will need to show a travel certificate of 6 months submitted by the PDI , if within this period you exit the country for a maximum of 15 days, you can still apply.
21	How will placements to the programme be allocated?	All those interested in participating in the Ireland WHA program should send an email to IRISHWHCHILE@VFSGLOBAL.COM from 9am on the 26 th of September. The appointment will be allocated on a first

ID	Question	Answer
22	I have a police certificate that was used for a different reason. Can I use the same police certificate for my application?	The certificate must have been issued no longer than 3 months prior to your application submission. In cases where the applicant has a criminal record, they must present a letter explaining the situation. Applications will be assessed on a case by case basis.
23	Can I send my application directly to the Irish Embassy or Consulate?	The applications can only be accepted by personal application at the VFS Application Centre in Santiago
24	Can I bring my wife/husband/partner/children with me to Ireland?	The authorizations are for individuals only. Holders of a working holiday authorization are not allowed to bring any family members.

25	Is there a limit of Working Holiday Authorisations to be issued?	The scheme is limited to 200 participants per year. These will be granted in 2 rounds of 100. Once the limit has been reached, the Embassy will announce the closure of the programme on its website Embassy Of Ireland, Chile Ireland.ie Ireland.ie
26	I have another question about the program that is not included in this FAQ. How can I find the answer?	Applicants with questions not included in this FAQ must any queries via the Embassy's Contact Us Page . We regret to inform that it will not be possible to answer these questions at the Application Centre in regards of this program.
27	For the Health Insurance , any provider is acceptable ?	Yes, you can purchase any health insurance from any company as long as it complies with the following: you have proof of comprehensive travel insurance valid for at least one year to cover medical emergencies and repatriation. The policy must clearly state your name, coverage dates, and confirm it includes full medical and hospital cover for the duration of your intended stay.

28	Can I apply to the Working Holiday Ireland if I am applying or have won another country's working holiday ?	No, in order to ensure all people are given a fair and treatment, only people applying for the working holiday Ireland may be eligible, if you get selected for another Working holiday programme, you will be disqualified from the Working Holiday Ireland.
